"Lead For America Fellowship: Lead For America's fellowship program recruits, trains, and places young leaders ages 21-30 in local governments or non-profits in their hometowns or home states, usually in economically distressed communities. For its 2019 cycle, Lead For America's fellowship program received 1,800+ registrations and 800+ completed applications from 250+ colleges and universities. 54 selected Fellows are serving 46 communities in 21 states, and over 50% of Fellows are people of color, 65% are women or gender non-conforming, 43% are Pell-grant eligible, and 31% are first-generation college students. The 2019 cohort includes Marine Corps veterans, Truman Scholars, Udall Scholars, and Division 1 athletes. 100% of Fellows are serving in communities or regions in which they have already lived. Before the two year fellowship begins, Lead For America hosts an in-person one month summer training to cultivate the leadership development and public administration skills to ensure Fellows can both make an immediate impact during their fellowship, and build the capabilities to become a transformational community changemaker in the long term. After the Catalyst Institute, 95% of surveyed participants said they would recommend the Catalyst Institute to others. The fellowship includes a living scholarship equal to the livable wage of the host community, as well as three all-Fellow retreats over the course of the two
